STALLION SERVICE CONTRACT - COOLED SEMEN

This agreement for the 20__ breeding season (Feb. 1 - June 30) is made and entered into by and between Cedar Ridge Ranch, herein designated Breeder and _____ herein designated Mare Owner. Mare owner agrees to Breed Mare _____ Breed _____ Reg. No. _____ to the stallion _____ Breed _____

Subject to the following conditions:

1. Fee: The stallion service fee is \$ _____. A nonrefundable booking fee of \$ _____ is due at signing and acceptance of this contract with a nonrefundable balance of \$ _____ payable before the semen is shipped and the mare is bred.
2. Collection/shipping Fee \$ _____ will be paid before each shipment of semen. There will be a maximum of three (3) shipments of semen. In the event the mare does not conceive on the third shipment, mare must be serviced at the farm. NO SHIPMENTS will be sent until receipt OF ADDITIONAL COLLECTION FEE.
3. Deposit on Equitainer \$ _____ Refundable after container is no longer needed. Damages will be assessed accordingly.
4. Reservation: Receipt of the above mentioned booking fee, a completed signed contract, and a PHOTOSTATIC COPY OF REGISTRATION PAPERS confirms the mares reservation to breed to the above named stallion. No mare will be serviced until such items are received.
5. Conditions: Stallion service will be provided to only healthy mares in sound breeding condition. In the event the mare is barren, Cedar Ridge Ranch requires the purchaser's veterinarian to submit a current negative intrauterine culture certificate (within 60 days) and certify the immunizations for equine rhinopneumonitis (equine herpes type I) have been current.
6. Purchaser shall not be entitled to a return of service unless conditions below are present. The mare will have the right of return to the above stallion in the 20__ breeding season ONLY.
 - A. If the mare does not settle during the present breeding season, she is eligible to return in 20 ____, if the purchaser submits a veterinarian's certificate to that effect.
 - B. If the mare is examined to be in foal but becomes barren during gestation, she is eligible for return if Cedar Ridge Ranch receives a veterinarian's certificate of barrenness within five days of examination.
 - C. If the mare aborts or produces a live foal that is unable to stand alone and nurse and subsequently dies, a veterinarian's certificate must be provided to Cedar Ridge Ranch within seven days from date of death.
 - D. In each and all cases, the required veterinarian certificates shall affirm that the mare had been immunized (see item 5 conditions). Where appropriate, the certificate shall confirm that the mare was properly cared for during gestation and was attended during foaling. Timely receipt of required certificates is a condition precedent to any return.
 - E. All rights of return to the stallion are subject to prepayment of costs.
7. Refund of Fees: This agreement shall be null and void and the purchasers shall be entitled to a refund of any amount paid if the stallion should die or become unfit for service prior to servicing the mare in the current breeding season.
8. Non Assignment: This agreement cannot be transferred or assigned by the purchaser. There shall be no right of return to the stallion if the mare is sold or otherwise changes ownership after being serviced by the stallion.
9. Governing Law: This contract shall be governed by the laws of Scott County, State of Iowa, and shall be binding upon the parties herein and their personal representatives.
